# Financial update from Northy:

### **Elections**

Jehde explained that we are electing three different types of roles today. They are open to all CSRA members. Those who have already applied but not yet received their welcome package are considered members for this purpose, and a two-week grace period will be given to anyone who is currently not a member. If a successful candidate is not officially a member after two weeks, the position will be considered vacant and another election will be held.

#### **Discord Administrators**

#### **Committee Leads**

Responsible for announcements, posts, and interactions on social media platforms and the website.

Elected: Remmyzilla and Northy as co-leaders with 12 unanimous votes.

#### **Website Committee Lead**

Responsible for managing the website's technical aspects and coordinating with Social Media team.

#### **Media Relations**

The Media Relations committee is a new role to promote the CSRA. Media Relations will function as a spokesperson for interviews and requests for information, prepare press releases, and work with the Social Media Committee. Members in a spokesperson role will not be anonymous.

### **Legal Committee**
